WHEREAS, the Township of Jefferson may, by resolution and without advertising for bids, in accordance with N.J.S.A. 40A:11-11 of the Local Public Contracts Law, purchase goods or services under the **New Jersey State Approved Co-op #65MCESCCPS, Educational Services Commission of New Jersey (ESCNJ) Co-op contracts entered into on behalf of said Commission;** and

WHEREAS, the Township of Jefferson has the need on a timely basis to purchase goods or services utilizing State contracts; and

WHEREAS, the ESCNJ contract **ESCNJ 16/17-45** was awarded to Turn-Key Technologies, Inc., 2400 Main Street Extension, Suite 12, Sayreville, New Jersey, 08872 for Wireless Duress Monitoring System and support; and

WHEREAS, the Township of Jefferson desires to purchase **Wireless Duress Monitoring System and support** in an **amount not to exceed \$115,000.00** through this resolution and properly executed contract, which shall be subject to all the conditions applicable to the current ESCNJ contract; and




