WHEREAS, the Township of Jefferson has the need on a timely basis to purchase goods or services utilizing State contracts; and

WHEREAS, **State Contracts #M-8000 (A82527 & A82528)** were awarded to **Rachles Michele Oil Co., Inc., 116 Kuller Road, Clifton, New Jersey, 07011** for regular gasoline; and


