**ORDINANCE #17-20**

**"ORDINANCE AMENDING CHAPTER 267 OF THE JEFFERSON TOWNSHIP MUNICIPAL CODE ENTITLED  
'FOOD ESTABLISHMENTS, RETAIL'  
AND CREATING A FEE FOR FOOD HANDLERS ATTENDING SPECIAL EVENTS"**

**BE IT ORDAINED** by the Township Council of the Township of Jefferson, County of Morris, State of New Jersey, that Chapter 267 of the Jefferson Township Municipal Code entitled "FOOD ESTABLISHMENTS, RETAIL" is hereby amended by creating subsection 267-4(A) entitled "Special Event Food-Handling Vendors" as follows:

**SECTION I**

**§267-4(A). Special Event Food-Handling Vendors.**

A person attending a special event located within the Township of Jefferson for the purpose of dispensing or selling food shall secure a permit from the Division of Health for each said event. The fee for such permit shall be \$50 per event.

**SECTION II**

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

**SECTION III**



**SECTION IV**

This Ordinance shall take effect immediately upon final publication as provided by law.


