**ORDINANCE #17-24**

**"ORDINANCE AMENDING CHAPTER 130 OF THE JEFFERSON TOWNSHIP MUNICIPAL CODE ENTITLED  
'VEHICLES AND TRAFFIC' AND MORE PARTICULARLY SUBSECTION 130-25 ENTITLED  
'SCHEDULE I: NO PARKING'"**

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Jefferson, County of Morris, State of New Jersey, that Chapter 130 of the Jefferson Township Municipal Code, entitled "Vehicles and Traffic" and more particularly Subsection 130-25 entitled "Schedule I: No Parking" is amended as follows:

**SECTION I**

§130-25, entitled "Schedule I: No Parking," shall be amended by adding the following no parking zones:

Waterside Drive, Shore Road, Bear Drive, Ludlow Street, Apple Trail, Spring Road, and McNabb Road - No parking within 50 feet on either side of the road, from the end of the paved portion of the road.

**SECTION II**

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

**SECTION III**

If any article, section, subsection, paragraphs, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

**SECTION IV**

This Ordinance shall take effect immediately upon final publication as provided by law.
