

## MUNICIPAL STORMWATER MANAGEMENT PLAN

### RESOLUTION OF APPROVAL PLANNING BOARD, TOWNSHIP OF LACEY

**WHEREAS**, the Township of Lacey has conducted a comprehensive study of the proposed "Pinelands Area" and "Non-Pinelands Area" municipal stormwater ordinances in connection with the periodic review of its Master Plan; and

**WHEREAS**, to N.J.S.A. 40:55D-28b3, a **MUNICIPAL STORMWATER MANAGEMENT PLAN** is an essential part of said Master Plan; and

**WHEREAS**, the Planning Board of Lacey Township has determined that the said Municipal Stormwater Management Plan is consistent with the goals and objectives of the Township of Lacey Master Plan update and that adoption and implementation of same is in the public interest and protects public health and safety and promotes the general welfare.

**WHEREAS**, the Mayor and Township Committee had final adoption of the "**Pinelands Area**" Ordinance on July 26<sup>th</sup>, 2007 and "**Non-Pinelands Area**" Ordinance on May 11<sup>th</sup>, 2006 which provide for amending and supplementing the Code of the Township of Lacey.

**WHEREAS**, the proposed Municipal Stormwater Management Plan was drafted by Remington, Vernick & Vena Engineers with an amended date of September 2007

**WHEREAS**, the proposed Municipal Stormwater Management Plan has been referred to the Planning Board of Lacey Township, in accordance with the referral powers provided by N.J.S.A. 40:55D-26 and 64; and

**WHEREAS**, the Planning Board of Lacey Township has reviewed the proposed Stormwater Management Plan and approves of the same.

**NOW, THEREFORE, BE IT RESOLVED**, by the Lacey Township Planning Board that the "Municipal Stormwater Management Plan be and hereby are approved.

**BE IT FURTHER RESOLVED**, that the Lacey Township Planning Board hereby recommends adoption of the Municipal Stormwater Management Plan contingent upon all mitigation projects in the Pineland Area to be reviewed and approved by the Pinelands commission;

**NOW, THEREFORE, BE IT FURTHER RESOLVED**, that certified copies of this Resolution shall be forwarded to the Mayor and Township Committee, and to the Township Clerk.
