The regular meeting of the Town Board was held on Wednesday, September 11, 2013, at 120 Stringham Road, Town of LaGrange. Supervisor Luna called the meeting to order at 7:00 p.m. The Town Clerk led the flag salute.

Supervisor Luna asked for a motion to accept the minutes for August 28, 2013. Councilman Jessup so moved, seconded by Councilman Bell. The motion carried unanimously.

Supervisor Luna asked for a motion to accept the monthly reports for August 2013. Councilman Jessup so moved, seconded by Councilman Bell. The motion carried unanimously.

Mr. Luna asked for a motion to re-appoint Robert Taft as Town Assessor. The term of office is six (6) years. Councilman Polhemus so moved, seconded by Councilman Dyal. The motion carried unanimously.

The Building Inspector requested Town Board approval to attend the NYS Building Officials Conference in Lake George scheduled for September 11, 2013 through September 13, 2012. The cost will not exceed \$500.00. Councilman Polhemus moved to approve the request, seconded by Councilman Dyal. The motion carried.

Supervisor Luna asked for Town Board approval to accept the name "Providence Way" for Providence Estates. There are no conflicts within the municipality, fire district or postal zone. Providence Way is a common driveway in Providence Estates.

Councilman Dyal moved to approve the name, seconded by Councilman Bell. The motion carried.

Mr. Luna asked for a motion to accept the bid from Environmental Consultants for the upgrade project for the Grandview Water District Booster Pump Station. The bid was the lowest of three bids and the amount was \$47,760.00. The other bids came in at \$95,000.00 and \$83,100.00 respectively. (SEE ADDENDUM)

Ms. Livigni stated that the proposed project had been approved after a Public Hearing in 2012, with a borrowing amount of \$221,000. In an effort to find the most cost effective way of resolving the ongoing problems in the district, Ms. Livigni and Environmental Consultants collected data to modify the proposed project. There will be some minor Change Orders within a short time of the commencement of the work, but overall the amounts of the Change Orders should not be too great. She added that Environmental Consultants knows the system very well and that they are the best choice to work on remediating the problems.

Councilman Jessup moved to award the bid to Environmental Consultants, seconded by Councilman Polhemus. The motion carried.

The Highway Superintendent requested Town Board's permission to award Materials and Street Sweeping Contracts for 2013-2014 to the lowest bidders. (SEE ADDENDUM – Lowest bids are in bold type.)

Councilman Dyal moved to award the bids to the lowest bidder, seconded by Councilman Bell. The motion carried.

Town Justice Stephen O'Hare requested approval for the Court Clerks, Sandra Dillon, Carolyn Harklerode and Nancy Baughman, to attend the NYS Association of Magistrates Court Clerks 2013 Annual Conference on October 6, 2013 through October 9, 2013.

Supervisor Luna made a motion to deny the request.

Councilman Bell asked why Mr. Luna wished to deny the request. Mr. Luna replied that it was too costly to send all of the Clerks. Ms. Harklerode's expenses will be paid by the Town of

Stanford; however the \$40 registration fee for the conference will be picked up by the Town of Lagrange.
Councilman Jessup seconded the motion. The motion carried.

Sina Macak addressed the Board. She congratulated Councilmen Bell and Jessup and Supervisor Luna on the Primary. She added that it was an obvious win which reflected the voters' confidence that things were being well run in the Town. She said that there had been outstanding voter turnout in La Grange. She complimented the Town Board on the renovations to Town Hall, both inside and out.


Councilman Bell moved to close the Public Comment, seconded by Councilman Polhemus. The motion was carried by all.

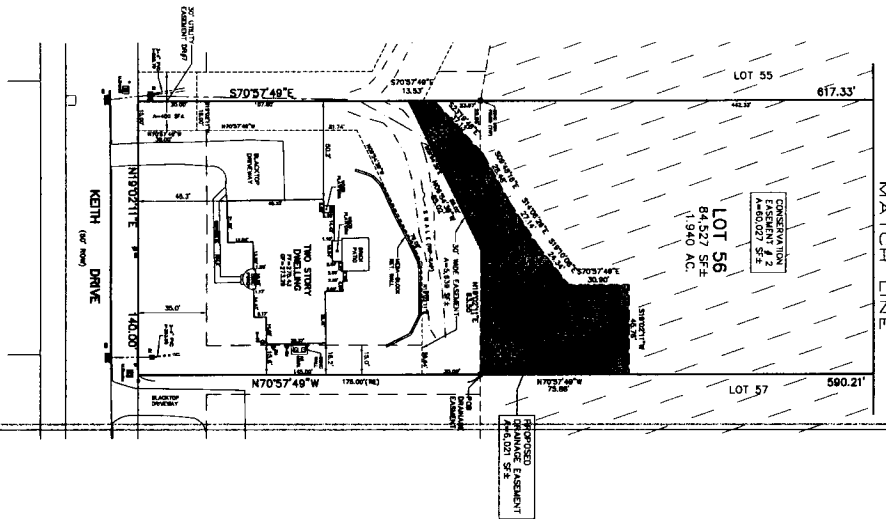
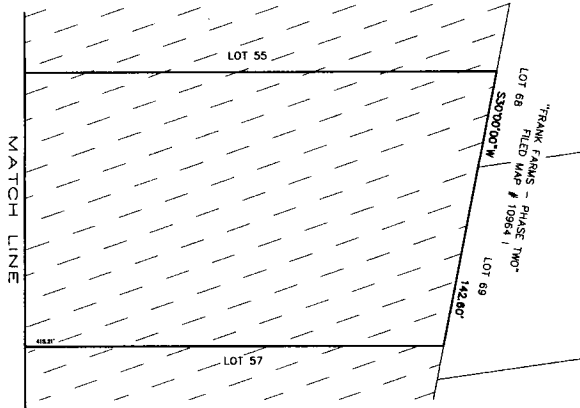
