II. Public Hearings

a. 11 West Main St. – Joseph Marshall (Lilly Belle Meads) – Paint awning & signage on windows Mr. Marshall and James Allein (CDC) were present at the meeting. The proposed project included painting the areas of the awning that had previously been pink and teal as well as his business's portion of the brown awning, black and some small window signage. S. Marshall noted that Mr. Marshall should discuss future expansion plans with Town Code Official Matt Fischione. J. Allein noted that in the future at this property the amount of signage per tenant will be evaluated and brought back to the HPC.
