

**TOWNSHIP OF LUMBERTON, NEW JERSEY**

**ORDINANCE NO. 2019-05**

**ORDINANCE SUPPLEMENTING CHAPTER 265 OF THE MUNICIPAL CODE  
OF THE TOWNSHIP OF LUMBERTON ENTITLED "VEHICLES AND TRAFFIC"  
TO CREATE A NEW SECTION ENTITLED "CROSSWALKS"**

**WHEREAS**, the Township Committee of the Township of Lumberton desires to improve safety conditions for both drivers and pedestrians; and

**WHEREAS**, N.J.S.A. 39:4-8 authorizes the Township to establish certain regulations in the interests of safety and expedition on municipal roadways; and

**WHEREAS**, the Township Committee believes a centralized schedule of crosswalks will serve those same interests and allow for the posting of appropriate signs and markings of said crosswalks.

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED** by the Township Committee of the Township of Lumberton, County of Burlington, State of New Jersey that Chapter 265 of the Township Code entitled "Vehicles and Traffic" be and is hereby amended and supplement to create a new section 265-78 and associated schedule to identify and formalize crosswalk locations within the municipality as follows:

**ARTICLE I. NEW SECTIONS**

The Township Committee supplements Chapter 265 of the Code to create a new Section 265-78 entitled "Crosswalks" to read as follows:

**§265-78 Crosswalks**

The streets or parts of streets described in Schedule XX attached to and made a part of this chapter are hereby designated as pedestrian crosswalks. The stopping or standing of vehicles within 25 feet of the crosswalks is prohibited. Appropriate pavement markers and signs may be installed on such streets or parts of streets consistent with the Manual on Uniform Traffic Control Devices and consistent with the provisions of this chapter.

The Township Committee supplements Chapter 265 of the Code to create a new Section 265-79 entitled "SCHEDULED XX: Crosswalks" to read as follows:

**§265-79 Schedule XX: Crosswalks.**

In accordance with the provisions of § 265-77, speed limits are hereby established upon the following described streets or parts thereof:

**ARTICLE II. REPEALER, SEVERABILITY AND EFFECTIVE DATE.**

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.
