**Committee Reports:**

**Public Works:** Mr. Hagaman reported the following: Public Works have been busy with maintenance to equipment, cutting of roadways, chipping, storm drain cleaning, and maintenance to fields, and landscaping at municipal building. Drainage pipes have been installed on 5<sup>th</sup> Avenue and pavement should begin shortly. Mr. Hagaman stated the municipality has been awarded a Clean Communities Grant in the amount of \$18,186.73.

**Development & Housing:** Mr. Hagaman reported everything is status quo.

**Department of Administration:** Mr. Gabris reported the following: Annual Community Day is scheduled for Saturday June 7<sup>th</sup> from 10 am – 2 pm. Organization, vendors and individuals are all welcome to join in the fun. The day will begin at 9am with a 5K Run supporting Mullica Township Wrestling Team. Mullica Township School will be holding a Bicycle Rodeo for Grades 3-6 from 10-12 and Cedar Creek High School will be

holding Clothing Drive. June 10<sup>th</sup> & 11<sup>th</sup> the Mullica Township 3<sup>rd</sup> Graders will be visiting Town Hall for their Annual Field Trip. Historical Society will meet June 17 at 7pm. Seniors Meeting will be held Wednesday, June 18th, at 12pm place to be determined.

**Department of Public Safety:** Mr. Riffle reported the following: Municipal Court collected \$38,929.50 for the month of March 2014 and the municipality retained \$17,965.06

Mayor Brown stated he received the following Report from the Fire Departments for the 1<sup>st</sup> quarter: total calls are 95, happy with Dispatch service, will continue to drill as a Township Fire Department, new well in service is performing good, Fire Department completed a ISO Audit, result of a motor vehicle accident which involved a fire truck has resulted in driver safety classes, man power issues are reported occasionally, and Elwood Fire Company had chevron safety stripping installed on three units.

**Department of Revenue & Finance:** Mayor Brown reported the State will not be issuing Homestead Rebates for the 2014 tax year. There is a possibility they will be granting the rebates in 2015, but there is no guarantee.

### **Correspondence:**

Resolution from Corbin City and Township of Hamilton opposing Senate Bill S-1801 and A-2621 seeking to authorize County Government to create County Tax Assessment and abolishing tax assessment at the local level.

Correspondence from DEP stating they will be accepting applications for Green Acres funding to acquire or develop land for recreation and conservation purposes.

Correspondence from Fleet Reserve Association requesting the Governing Body establish veterans set aside program.

Request from Assemblyman Chris Brown that we adopt a Resolution supporting A-1021, which would require revenues from the energy receipts to go directly to municipalities and for the State to restore municipal aid.

### **Old Business:**

**Discuss Lease / Hilda Frame School / Historical Society:** Ms. Siebold updated the Governing Body stating the School Board Solicitor forwarded changes which need to be reviewed. Mr. Gabris suggested a Resolution of the Governing Body to the School Board may help speed up the process. Mayor Brown stated we had discussed an approving Resolution once the lease was finalized.
