# **Committee Reports:**

**Public Works:** Mr. Riffle reported the following: We are inundated with brush because of the hurricane and the unexpected wet heavy snowfall, chipping we estimate is about three weeks behind schedule. The truck and chipper will be out tomorrow. The transfer station will be open this Friday the 16<sup>th</sup> for flood debris collection; this will be the last additional drop off day. Debris collected at the Transfer Station for November 3<sup>rd</sup> to November 11<sup>th</sup> has been 63.96 tons (127,920 lbs.) bulk material, construction debris and items damaged from the flooding. Ten 40 yard containers were filled with items damaged by flooding in our Mullica River Communities. These items were unloaded out of the resident's cars, trucks, and trailers by hand by the Public Works Department into the bucket of our loader. We also collected 48.35 tons (96,700 lbs.) of household solid waste of which 1/3 was caused by hurricane sandy. In total over the last two weekends working 7 full days at the transfer station we collected 112.31 tons (224,620 lbs) of trash and debris. Total tipping fees for dates above was \$10,271.32. Mr. Riffle commended Superintendent Ayers and his crew for their work during the hurricane and recent snow storm.

**Housing & Development:** Mr. Gabris reported the following: For the month of October the Construction Department issued 21 new permits and 3 updates. The Construction Office collected \$3,214.00 in fees of which \$136.00 is remitted to the State. The Zoning Department issued 9 Zoning Permits, 7 Maintenance Certificates,

and collected \$1,625.00. Mr. Gabris congratulated and thanked everyone who assisted residents affected by Hurricane Sandy, especially the Mullica Teachers Union who reached out last Friday.

**Revenue & Finance:** Mayor Brown reported the following: If you have not already paid your 4<sup>th</sup> Quarter property taxes, the Governor has extended the grace period to this Friday. The deadline for filing Homestead Benefit applications has been extended to Friday, December 14<sup>th</sup>.
