

AN ORDINANCE AUTHORIZING, ESTABLISHING AND PROVIDING FOR THE ELECTION PROCEDURE TO BE FOLLOWED FOR THE GENERAL MUNICIPAL ELECTION TO BE HELD APRIL 5, 2016 IN THE CITY OF OSAGE BEACH, MISSOURI.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF OSAGE BEACH, MISSOURI, AS FOLLOWS:

Section 1. That pursuant to the provisions of the Missouri Comprehensive Election Act of 1977, Chapter 115 RSMo, the City of Osage Beach will hold its General Municipal Election on the 5TH day of April, 2016 for the following offices:

<u>OFFICE</u>	<u>TERM</u>
Mayor	Two Year Term
Alderman from Ward I	Two Year Term
Alderman from Ward II	Two Year Term
Alderman from Ward III	Two Year Term
City Collector	Two Year Term

Section 2. That the dates for filing for the above offices shall commence on December 15, 2015. Candidates must file a Declaration of Candidacy with the City Clerk, 1000 City Parkway, Osage Beach, beginning at 8:00 a.m. on Tuesday, December 15, 2015 and continuing during regular business hours between 8:30 a.m. and 5:00 p.m. Monday through Friday, until Tuesday, January 19, 2016 when the hours of filing shall be 8:00 a.m. until 5:00 p.m. City Hall will be closed on December 24-25, 2015; January 1, 2016 and January 18, 2016 therefore, no filings will be accepted on those dates.

Section 3. Candidates who file a declaration of candidacy with the City Clerk prior to 5:00 p.m. on the first day for filing, the City Clerk will determine by random drawing the order in which such candidates' names shall appear on the ballot. Each candidate shall draw a number at random at the time of filing and the number shall be recorded on the candidate's declaration of candidacy form. The names of candidates filing on the first day of filing for each office on each ballot shall be listed in ascending order of the numbers so drawn.

Section 4. This Ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and approval by the Mayor.

Section 4. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.
