PLEASE TAKE NOTICE that in accordance with Article 25-AA, Section 303-b of the NYS Agriculture and Markets Law, a public hearing will be held by the Planning and Economic Development Committee of the Monroe County Legislature on July 23, 2018 at 5:15 P.M. at the Legislative Chambers in the County Office Building, 39 West Main Street, Rochester, New York regarding addition to the Monroe County Western Agricultural District #5, located in the Town of Parma. The public hearing is being held to give the public an opportunity to comment on: (1) the proposed addition to the District; and (2) the recommendations of the Monroe County Agricultural and Farmland Protection Board.

The existing District occupies a portion of the Town of Parma. The following parcel is proposed to be added to the District:

Monroe County Western Agricultural District #5:

- 4930 West Ridge Road, Town of Parma, consisting of approximately 64.84 acres, tax account number 072.01-2-22.1, owned by Duncan Family Farms Northeast.

The Monroe County Agricultural and Farmland Protection Board have reviewed the proposed addition to the District and recommends that the District be modified to include the additional parcel.
