**Work Session**

A work session of the Town Board of the Town of Pendleton was held at the Town Hall, 6570 Campbell Blvd., Pendleton, N.Y. on the 29<sup>th</sup> day of June 2015. The meeting was scheduled for 7:00 P.M.
