Motion by Councilman Murdock to approve the bills in the amount of \$61,421.92, paying with check numbers 23165 through 23211. Seconded by Councilman Brost. Motion passed 3-0.

Motion by Councilman Murdock to authorize the mayor to sign the letter of general support for the Pinedale Dog Park, after adding the following to the letter: "Multiple sites available, not to be specified to one site; Provide adequate land space, not to be a specified acreage. Town will provide liability insurance. Seconded by Councilman Brost. Motion passed 3-0.

Motion by Councilman Murdock to authorize the mayor to sign the FAA Grant for the land acquisition at Ralph Wentz Field in the amount of \$140,586.00. Seconded by Councilman Brost. Motion passed 3-0.

Motion by Councilman Murdock to authorize Hayley Ryckman to apply for the WYDOT TAP Grant for moving the hawk light from Pine Street and Lake Ave. to the American Legion Park location at Pine Street and Lincoln Ave., and ADA compliance for the Boyd Skinner rock pathway. Seconded by Councilman Brost. Motion passed 3-0.

Motion by Councilman Murdock to adjourn. Seconded by Councilman Brost. Motion passed 3-0.
