C. 2017-2018 Tax Incremental Finance Projects

TIF projects costs will be included in a new annual report as required by the Department of Revenue. Listed cost estimates are somewhat fluid as site preparation costs may fluctuate dependent on the conditions. The DOT requires that all Safe Route to School projects be stamped by an engineer. Such engineered costs were estimated but unconfirmed by an engineering firm.

6. Conditional Use Permit for a Tourist Rooming House located at 23148 Lake Rd (discussed)
7. Consideration of increasing the wage for the Electric Superintendent to \$40.00 per hour effective June 30, 2017 (discussed)
8. Discussion of TYSC Operations Proposal

Trempealeau Youth Sports Club is considering to install a dugout approximately 31.875' x 6.375'. TYSC asked if a building permit is required. Staff will follow up with the building inspector and TYSC.

TYSC requested that the lease between TYSC and the Village be revised in the following:

- Mow the main field and T-ball field on Park Rd.
- Utility Bill – Water/electrical (average from 2015-2016 = \$274.01/mo)
- Replacing ball field lights and labor when needed (tariff)
- Turning water on/off (spring/fall)
- Tree stump removal
