

- A motion by Legislator Rodriguez was made to accept the July 6, 2011 Committee Meeting Minutes, Seconded by Legislator Sweeney, all were in favor, Carried.

**Resolutions:**

- 1.) Resolution Draft No. 0802 - August 9, 2011: Authorizing The Chairman Of The Ulster County Legislature To Apply For And Accept Section 5311 Federal And State Funding Under The Terms Of An Existing Continuing Agreement With The New York State Department Of Transportation For The Purchase Of Two Diesel Cutaway Buses For Fiscal Year 2012 - Department Of Public Transportation (Ulster County Area Transit)

Legislator Sweeney asked why the county is buying diesel instead of hybrids. A - The smaller buses are diesel, designed for high speed - rural areas. The hybrids are more efficient for city limit driving - stop and go. The buses for this resolution are for rural usage. Legislator Rodriguez asked what are we doing with the buses being replaced. A - Unsure, Chairman Maloney to advise.

**Motion offered to move Resolution forward by Legislator Rodriguez, Seconded by Legislator Sweeney, All in Favor, Unanimously Carried.**
