Mary introduced a resolution Authorizing the Chairman to Enter into Agreement with Rebecca Conger-Glaser, Program Consultant for Ulster County DWI Impact Panel for the period 1/1/99 - 12/31/99. Consultant fee plus expenses in the amount \$14,660.00. Moved by Legislator Smith, seconded by Legislator Bertone. No discussion. Unanimously carried. Mary introduced a resolution for Continuation of existing STOP-DWI Programs, Senior Probation Officer, term 1/1/99 thru 12/31/99 in the amount of \$42,574.00; Mental Health (1 Alcohol Abuse Counselor, term 1/1/99 thru 12/31/99 in the amount of \$25,910.00; District Attorney, (2 Assistants), term 1/1/99 thru 12/31/99 in the amount of \$50,375.00. Total \$118,859.00. Moved by Legislator Every, seconded by Legislator Bertone. No discussion. Unanimously carried. (Legislators Felicello, Busick, Every, Lent, Roberti, Bertone, Smith all in favor).

Moved by Legislator Every, seconded by Legislator Smith. No discussion. Unanimously carried. (Legislators Felicello, Busick, Every, Lent, Roberti, Bertone, Smith all in favor.

Mary introduced a resolution authorizing the chairman to enter into agreement with various municipalities for supplying of data and information concerning DWI cases for 1999, in the amount of \$10,000.00. Moved by Legislator Bertone, seconded by Legislator Lent. No discussion. Unanimously carried. (Legislators Felicello, Busick, Every, Lent, Roberti, Bertone, Smith all in favor).
