

## TOWNSHIP OF UPPER CHICHESTER

November 14, 2013

### **I. CALL TO ORDER**

*The regular meeting of the Board of Commissioners was called to order by Nicole Whitaker, President, at 7:30 P.M., in the Meeting Room of the Municipal Building, Furey Road, Delaware County, Pennsylvania. Ms. Whitaker conducted the Pledge of Allegiance.*

### **II. ROLL CALL**

*Roll was called as follows: Mr. Baiocco, Mr. Gaudio, Mr. Viscuso, P.E., Ms. Whitaker, Mr. Michael Sheridan, Esq., Mr. Raikowski, Mr. Neary, Ms. Devlin. All present unless otherwise noted.*

### **III. ENGINEER'S REPORT**

- 1. Mr. Viscuso presented the Engineer's report.*
- 2. Mr. Viscuso said that they would need to release funds on the ball field project, which was under way. He was waiting on a number.*
- 3. Moved by Mr. Neary, seconded by Mr. Baiocco, that the Board adopt Resolution 13-32 to release escrow funds on the Maple Zone project. Question? Motion carried without dissent.*
- 4. Moved by Mr. Neary, seconded by Mr. Raikowski, that the Board adopt Resolution 13-33 to release the final escrow release for the Wawa project. Question? Mr. Baiocco asked if they should hold the escrow money until the final few items were straightened out. Motion carried without dissent.*

### **IV. COMMENTS OF CITIZENS**

*Dr. William Ware, Cherry Tree Road, expressed concerns with the new traffic patterns and markings along the roadway after the work on the new Wawa was completed.*

#### **A. Highway & Sanitation, Zoning & Planning – Mr. Raikowski, Chairman**

3. Moved by Mr. Neary, seconded by Mr. Raikowski, that the Board approve the payment of the exoneration refund list for the month of November. Question? Motion carried without dissent.

1. Mr. Gaudioso highlighted the monthly Recreation Department report, noting that they were following up on the tree issue at the Willowbrook Shopping Center and the issue with the bus stops not being ADA compliant the Concord Valley Road dedication

**E. Public Safety – Ms. Whitaker, Chairman**

1. Ms. Whitaker presented the monthly Police Department Report

2. Ms. Whitaker noted Sun Centers Studios expansion that is being discussed and other issues that go along with that, such as the Transportation Bill.

- 2. Moved by Mr. Neary; seconded by Mr. Baiocco to award a paving contract for Village Way to Gessler Landscaping in the event that Travelers does not get the road paved by November 25. Question? Motion carried 3-2, with dissent from Ms. Whitaker and Mr. Raikowski.*
