Tom Ulrich, Board of Education member, suggested a meeting to include City Council, the Board of Education, County Engineer and City Engineer and our state legislators to discuss issues of mutual concern, particularly the safety of children walking to school or to their bus stop.

President Fanucci said he and the other Council members would be in favor of such a meeting.

An attorney was present and thanked Council for agreeing to delay adoption of the ordinance proposing inspection fee increases.

Greg Pacitto, President of PBA Local 266, spoke about the recent changes to the compensatory time policy. He described how the PBA agreed to take comp time in an effort to save the city money by not being paid overtime. He complained about not getting a response from Business Administrator William Lutz.

Administrator Lutz explained that compensatory time is an unfunded liability. He explained that more personnel and comp time cannot be expected together. He said the issue is still under review.

Joseph Pagano, Vineland Police Officer, noted the policy that appears to affect only the police department.

Mayor Bermudez stated the administration will re-evaluate the comp time issue.
