The Pre-Meeting Conference of the City Council of the City of Vineland was called to order by the President, Anthony R. Fanucci.

The Municipal Clerk stated Public Notice of this meeting, pursuant to the Open Public Meetings Act, has been given on January 15, 2013 by the City Clerk in the following manner:

1. Posting written notice on the official bulletin board in the lobby of the City Hall on;
2. Providing written notice to the offices of The Daily Journal and The Press of Atlantic City;
3. Filing written notice in the office of the City Clerk of the City of Vineland.

President Fanucci asked if anyone from the public wished to speak. There was no public comment.

The Municipal Clerk reviewed the changes to the agenda since the April 2 work session. A revised version of Ordinance No. 2013-15 was distributed to be more specific concerning the garage on the property. A revised version of Resolution No. 2013-168 was distributed, correcting a typographical error in the title. A revised version of Resolution No. 2013-176 was distributed to reflect a change in the effective date coinciding with the date of closing. Resolution No; 2013-177, acknowledging the filing of a business name for the conduct of a taxicab owner's license, was added. This was added because the NJ Motor Vehicle Commission is now requiring the taxicab owners be business entities instead of individuals. Resolution No. 2013-178, authorizing the issuance of original and renewal taxicab licenses for the year 2013, was added. Resolution No. 2013-179, authorizing an agreement for professional services with the law firm of Testa Heck Scrocca & Testa, P.A., Vineland, NJ to perform the services of tax attorney for the City of Vineland, was added.

The idea of adjusting the start time of meetings was briefly discussed. Council members and staff were in agreement that consideration will be given to amending the start time for Work Sessions and Pre-Meeting Conferences to be 5:30 p.m. and Regular Meetings to begin at 6:00 p.m. The matter will be presented with the preparation of a resolution to be considered at the April 23 regular meeting.
