

**TOWNSHIP OF ROBBINSVILLE COUNCIL**  
**Regular Meeting**  
**April 13, 2017**

**CALL TO ORDER**

The regular meeting of the Township Council of the Township of Robbinsville was called to order on April 13, 2017 at 7:00 p.m. at the Municipal Building located in Robbinsville. Mr. Schuberth, Council President, presided over the meeting.

**ROLL CALL**

The call of the roll showed the following to be present: Council President Schuberth and Council Members Ciaccio, McGowan, and Witt. Vice President Calcagno was absent. Also present were: Chief Financial Officer Bauer, Administrator Tozzi, Director of Public Works Colarocco, Communication and Public Information Officer Nalbone, Constituent Relations Specialist Stephens, Police Chief Nitti, Lt. Clifton, Attorney Roselli, Associate Attorney Renaud and Deputy Municipal Clerk Dupnak.

**SUNSHINE STATEMENT**

The Deputy Municipal Clerk read the following statement: Adequate notice of this meeting has been provided as required under Chapter 231, P.L. 1975, specifying the time and place, with such notices being sent to the Times of Trenton and the Trentonian and being posted on the Municipal Building Public Notice Bulletin Board.

**PLEDGE OF ALLEGIANCE**

The Township Council members present led the public in the salute to the flag.

**APPROVAL OF MINUTES:**

Executive Meeting – March 23, 2017

Mr. Witt offered a motion to approve the above meeting minutes. The motion was seconded by Ms. McGowan.

**REPORTS OF COUNCIL MEMBERS**

Ms. Ciaccio had nothing to report.

Ms. McGowan said that the Economic Development Advisory Committee met last night and finalized plans for their awards dinner, which will be held on October 12<sup>th</sup>. She said this year, they

are going to announce the award winners prior to the event, in hopes they will bring their friends and family. She said they also spoke about Community Day, and the ideas and plans for this year.

Ms. McGowan said that she and Mr. Witt met on Tuesday with the subcommittee for Town Center South. She said they are still in stages of discussion and no decision has been made. She said they will be meeting weekly to fine tune things.

Mr. Witt said Council took action to designate Capadagli as the conditional developer of Town Center South and he explained further. He said because of the size of this project we will be involving the public, and there will be several public participation sessions. He said that Town Center South Redevelopment is part of the Master Plan and everything the Township has been doing has included the development on that side of Route 33. Mr. Witt said this is new to the process, but it is not new to the plan of the vision of Robbinsville as a whole. He said it's a unique vision and it will take some time to get there. He said there will be various times for the public to participate, get a sense of what is happening, and be able to give feedback. Mr. Witt said the Planning Board meeting was cancelled due to lack of a quorum.

Ms. Ciaccio said RMAPSA had an event at the Senior Center last Wednesday that was very well attended. She said it was very interesting and there were good speakers including: Mercer County Prosecutor Angelo Onofri and Sergeant Scott Kivet. Ms. Ciaccio said she learned a lot, and she thinks it should be done more often. She thanked the Administration and Mayor Fried for putting together the presentation.

Mr. Witt said the hard work and effort that goes into these volunteer boards is tremendous. He said people don't understand how pervasive of a problem drugs are, and we are not immune—not even in Robbinsville. He said it's very important to get that message out there, and he's proud that Robbinsville is making an effort to get it out there.

Ms. McGowan said she is part of a National Organization called the National Foundation of Women's Legislators. She said they have the opportunity to partner with Google where they will provide a screening with regard to computer coding. She said she wanted to bring it up tonight for the administration and the schools to work together and see if there was any interest. She said it would be free and she explained it in further detail.

Ms. Tozzi said she thinks it's a great idea.

Mr. Schuberth said that three of our officers from the Police Department received a well-deserved promotion: Lieutenant Christopher Clifton, Sergeant Scott Kivet, and Sergeant Mike Farrell. He congratulated them and thanked them for their service. He said the annual Easter Egg Hunt was a huge success.

Mr. Schuberth spoke about his involvement in the National Alliance on Mental Illness in Mercer County. He said the organization puts together a walk every year to raise money, and so far this year, Team Robbinsville raised over \$10,000.00. The walk is held on May 6th at 9:00 a.m. at the Educational Testing Center in Princeton and everyone is welcome to attend.

Mr. Nalbhone said he doesn’t know if we have live capability, but it is normally posted twelve hours later.

## 2017 ANNUAL MUNICIPAL BUDGET

### Budget Discussion

Mr. Schuberth explained how the introduction of budget process works. He thanked the Administration for their work in preparing the budget. He said we are going to hear from Chief Nitti tonight because the Municipal Budget, specifically the capital portion, includes an appropriation for a million dollars at which we would fund a firing range in Robbinsville that would be accessible to the police department.

Chief Nitti said , they currently use the Mercer County Prosecutor’s range in Hopewell. He said there are a lot of other agencies including the Mercer County Police Academy that utilize that range, making it almost impossible to get time there. He explained further.

Ms. McGowan said she thought we worked at the Hamilton range.

Chief Nitti said their range is under construction at the present time.

Ms. McGowan asked if other towns would participate, so we could enter into some shared services agreements. Chief Nitti said yes, it would be all of the surrounding towns in Mercer County.

Ms. McGowan asked where the firing range would go.

Chief Nitti said that needs to be discussed. He said they need about a half of a football field size area to do this.

Mr. Witt said the opportunity for a shared services agreement is key.

Mr. Schuberth asked what the typical turnaround time is for having that built. Chief Nitti said anywhere from nine months to a year.

Amendments to the Budget:

Mr. Schuberth explained the changes to the budget.

Mr. Colarocco explained the budget line item for Community Service. He said we are required to reimburse any homeowner’s association for any services that we provide to the rest of the town such as garbage removal, street lighting and snow plowing.

A motion was made by Mr. Witt and seconded by Ms. McGowan to make the following changes to the budget that was presented by Mayor Fried:

Mr. Witt said the fiscal stability demonstrated by the township is unheard of. He said other various townships' taxes keep going up. He said the net impact here slowly increases, but we're responsible for less than 25% of your tax dollars. He said to be able to manage that and provide the services, such as the police and fire is a testament to the people who work here.

Mr. Schuberth said just to be clear, on the last page of the budget, the increase in appropriations of \$33,000 had no impact on the projected tax rate. He said we still intend to reduce the municipal tax rate.
