ORDINANCE NO. 2171

AN ORDINANCE AUTHORIZING EXECUTION OF AN INTERGOVERNMENTAL COOPERATIVE AGREEMENT BETWEEN THE WARREN COUNTY R-III SCHOOL DISTRICT AND THE CITY OF WARRENTON, MISSOURI FOR SECURITY SERVICES

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF WARRENTON, MISSOURI, AS FOLLOWS:

SECTION I. That the City of Warrenton enter into a Intergovernmental Cooperative Agreement between the Warren County R-III School District and the City of Warrenton, Missouri for employment of police officers for security services to interact with students and school faculty and to promote the safety of children, school district patrons, and visitors while they are attending sports and social activities on school properties for of each school year and for security services for School Board meetings on school property as set forth in the Agreement attached hereto and made a part of this Ordinance by reference.

SECTION II. That the Mayor is hereby authorized and directed to execute on behalf of the City said Intergovernmental Cooperative Agreement and to do all things necessary to complete this transaction.

SECTION III. All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.


SECTION IV. This Ordinance shall take effect and be in full force from and after the passage and approval thereof.



**INTERGOVERNMENTAL COOPERATIVE AGREEMENT BETWEEN THE
WARREN COUNTY R-III SCHOOL DISTRICT AND THE CITY OF WARRENTON,
MISSOURI FOR SECURITY SERVICES**

WHEREAS, pursuant to Chapter 70 of the Revised Statutes of Missouri, governmental entities, including cities and school districts, are authorized to enter into agreements to provide a common service; and

WHEREAS, the City and the School District both have an interest in the safety of children, elected officials, school district patrons and visitors while they are attending School Board meetings, sports and social activities on school properties.

NOW, THEREFORE, in consideration of the mutual agreements of the parties as provided herein, the City and the School District agree as follows:

1. The City will supply off duty police officers to provide security services for School Board meetings, sports and social activities on school property based upon the request of the School District. Requests must be submitted to the Warrenton Chief of Police. The City will pay for officers at the current hourly rate or overtime rate as required by law.
2. In consideration of the City's agreement to employ such police officer to ensure an atmosphere of safety and security the District agrees to reimburse the City in an amount equal to the salary paid for such employees during such period, together with an amount equal to such employee's retirement contribution of 5% and an amount equal to ordinary employment taxes and workmen's compensation insurance costs attributable to such employee during such period.
3. The City will bill the District for the amount due on or around the first day of each month for the previous month's services. The District will pay the City on or before the twenty-third day of each month for said amount billed.
4. The Parties agree that the School District does not intend to employ such persons.
5. This Agreement may be terminated by either parties giving to the other sixty days written notice of the termination thereof.
6. This contract shall be effective for a period of one (1) year at which time this Contract will be subject to renegotiation or it may be terminated at that time upon mutual written agreement of both parties. If not terminated, it shall automatically renew for successive one (1) year periods.

IN WITNESS WHEREOF, the Parties have executed this Agreement effective as of July 1, 2014 as authorized by Ordinance of the City and by Resolution of the District.
