**ORDINANCE NO. 2225**

**AN ORDINANCE AUTHORIZING EXECUTION OF AN AGREEMENT BETWEEN AGAPE MINISTRY AND THE CITY OF WARRENTON, MISSOURI**

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF WARRENTON, MISSOURI, AS FOLLOWS:

SECTION I. That the City of Warrenton, Missouri enter into an agreement with Agape Ministry, under the terms and conditions as set forth in the contract attached hereto and made a part of this Ordinance by reference.

SECTION II. That the Mayor is hereby authorized and directed to execute on behalf of the City a Contract from July 1, 2015 thru June 30, 2016 and to do all things necessary to complete this transaction.


SECTION III. All ordinances or parts of ordinances in conflict with the Ordinance are hereby repealed.

SECTION IV. This Ordinance shall take effect and be in full force from and after the passage and approval thereof.



**SERVICE AGREEMENT**

Between the City of Warrenton, Missouri, a municipal corporation, hereinafter called CITY and the Agape Ministry of Warrenton, a Missouri not-for-profit agency, hereinafter called AGAPE is entered into this Agreement the 1<sup>st</sup> day of July, 2015.

The CITY and AGAPE agree as follows:

1. AGAPE will provide direct services to indigent persons and their families. These direct services will be available to any indigent individual residing in the City of Warrenton.
2. AGAPE will provide the following direct services to those persons identified in paragraph 1; providing food assistance, clothing, Salvation Army services, Share-A-Christmas Program, school supplies, partial payment of overdue bills and prescriptions, and giving referrals to appropriate agencies.
3. For said services of paragraphs 1 and 2, the CITY will pay to AGAPE the amount of \$18,000 for the term of this Agreement.

The term of this Agreement shall begin on July 1, 2015 and terminate on June 30, 2016.

IN WITNESS WHEREOF, the CITY and AGAPE hereto have executed this Agreement this 17<sup>th</sup> day of June, 2014.
