

**AN ORDINANCE AMENDING SECTION 705.210 OF THE MUNICIPAL CODE OF THE CITY OF WARRENTON, MISSOURI ESTABLISHING RATES FOR THE USE AND CONSUMPTION OF WATER WITHIN AND OUTSIDE THE CORPORATE LIMITS OF THE CITY OF WARRENTON.**

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF WARRENTON, MISSOURI, AS FOLLOWS:

SECTION I. That Section 705.210 of Chapter 705 of Title VII of the Municipal Code of the City of Warrenton is hereby amended effective August 1, 2015.

SECTION II. That Section 705.210 of Chapter 705 of Title VII of the Municipal Code of the City of Warrenton shall, as amended, be in words and figures as follows effective August 1, 2015.

A. The Director of Public Works shall cause to be read all business, commercial and contract meters monthly, and the Finance Officer shall cause monthly water bills to be made from said reading, which bill shall be collected monthly.

B. The Director of Public Works shall cause to be read all residential meters monthly and the Finance Officer shall promptly cause statements from said reading to be made and delivered.

C. Water Rates.

**1. CITY RESIDENTIAL**

1,000 gallon minimum- \$ 6.26 per month  
All over 1,000 gallons - \$ 4.04 per 1,000 gallons per month

**2. CITY INDUSTRIAL AND COMMERCIAL**

1,000 gallon minimum- \$10.70 per month  
All over 1,000 gallons - \$ 4.29 per 1,000 gallons per month

**3. OUTSIDE CITY LIMITS - RESIDENTIAL**

1,000 gallon minimum- \$ 19.90 per month  
All over 1,000 gallons - \$ 8.53 per 1,000 gallons per month

**4. OUTSIDE CITY LIMITS - COMMERCIAL AND INDUSTRIAL**

1,000 gallon minimum- \$20.94 per month  
All over 1,000 gallons - \$ 9.02 per 1,000 gallons per month

5. BULK SALES

\$ 1.00 per 50 gallons

6. *Fire hydrant meters.* Fire hydrant meters used for construction purposes will be charged a monthly fee based upon the amounts stated above or twenty-five dollars (\$25.00) per month, whichever is greater.

7. *Temporary water construction fee.* A fee of twenty-five dollars (\$25.00) shall be charged at the time a building permit is issued. The water usage is limited to construction only and excludes jetting of trenches, foundations or watering of lawns. The period covered by this fee will be the lesser of ninety (90) days or until the occupancy permit is issued. If a meter has not been installed after this period, the connection will be considered illegal and City ordinances regarding illegal connection will be enforced.

D. Statements for all commercial and residential use of water shall be paid on or before the fifteenth (15th) day of the month following the month the bill was mailed to the user.

SECTION III. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION IV. This ordinance shall take effect and be in full force from and after the passage and approval thereof.


