

**AN ORDINANCE AMENDING SECTION 700.120 OF THE MUNICIPAL CODE OF THE CITY OF WARRENTON, MISSOURI ESTABLISHING RATES FOR SEWER SERVICE WITHIN AND OUTSIDE THE CORPORATE LIMITS OF THE CITY OF WARRENTON.**

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF WARRENTON, MISSOURI, AS FOLLOWS:

SECTION I. That Section 700.120 of Chapter 700 of the Municipal Code of the City of Warrenton is hereby amended effective August 1, 2016.

SECTION II. That Section 700.120 of the Municipal Code of the City of Warrenton shall, as amended, be in words and figures as follows effective August 1, 2016.

**SECTION 700.120: RATES**

The monthly rates required and which shall be charged by the City of Warrenton, Missouri for sewerage service furnished or available by the City's sanitary sewerage system shall be based upon the quantity of water used and shall be measured by the water meter or meters installed on the premises served or for which service is available, unless suitable waste water measuring and recording equipment is furnished and maintained by the person receiving service, and said charges shall be as follows:

**1. WARRENTON RESIDENTIAL AND TRUESDALE RESIDENTIAL**

1,000 gallon minimum- \$ 10.64 per month  
All over 1,000 gallons - \$ 3.68 per 1,000 gallons per month

**2. CITY INDUSTRIAL AND COMMERCIAL**

1,000 gallon minimum- \$11.31 per month  
All over 1,000 gallons - \$ 3.81 per 1,000 gallons per month

**3. OUTSIDE CITY LIMITS - RESIDENTIAL**

1,000 gallon minimum- \$21.27 per month  
All over 1,000 gallons - \$ 7.35 per 1,000 gallons per month

**4. OUTSIDE CITY LIMITS - INDUSTRIAL AND COMMERCIAL**

1,000 gallon minimum- \$22.60 per month  
All over 1,000 gallons - \$ 7.58 per 1,000 gallons per month

5. Inside city limits where there is no meter reading, there shall be a fixed rate of \$27.65 per month.


6. Outside city limits where there is no meter reading, there shall be a rate of \$35.77 per month.

7. In addition to the charges prescribed herein, all existing or future industrial contributors which discharge processed waste water into the sanitary sewer system shall pay an industrial cost recovery charge to the City as prescribed in the industrial cost recovery charge ordinance.
8. Any industrial, commercial, or other contributor who discharges processed waste water or other waste water into the sanitary sewer system which contains more than 2.5 pounds of BODs per 1,000 gallons and/or more than 3 pounds of suspended solids per 1,000 gallons, shall pay an additional charge of \$0.26 per pound for each pound of BOD in excess of 2.5 pounds per 1,000 gallons and \$0.17 per pound for each pound of suspended solids in excess of 3 pounds per 1,000 gallons.
9. Any industrial, commercial or other contributor who discharges waste water into the sanitary sewer system and who
  - a) has a suitable sampling site and flow measuring device and
  - b) discharges 100,000 gallons or less per day average for the month shall be entitled to a monthly discount from the charges set forth in Paragraph 4 above as follows:
    - 1) If the monthly average of discharge contains 50 ppm BOD and Suspended Solids or less, the charge for all gallons exceeding the first 1,000 gallons shall be \$5.28 per 1,000 gallons per month, and
    - 2) If the monthly average of discharge contains 51 to and including 125 ppm BOD and Suspended Solids, the charge for all gallons exceeding the first 1,000 gallons is \$7.07 per 1,000 gallons per month.

SECTION III. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION IV. This ordinance shall take effect and be in full force from and after the passage and approval thereof.
